

Dear Captain/Owner:

Thank you for your interest in joining [e-yachts.info](http://e-yachts.info), the internet clearing house in the Caribbean. Following, please find information regarding [e-yachts.info](http://e-yachts.info) policies, listing agreement, forms & a list of the documentation necessary for our files. Please contact [e-yachts.info](http://e-yachts.info) with any questions or comments.

1. Two page listing agreement [e-yachts.info](http://e-yachts.info) subscriber rates are \$150 per month and 1% of a charter booked (or a minimum of \$30 per charter). Please execute and return the listing agreement along with the initial fee of \$150. We accept MC and VISA. A credit card authorization form is also included in this package for your convenience.
2. Two years blank calendar sheets - As we will be managing your calendar, take a long look at the calendars and block out any dates you do not want offered for charter – including holidays, self bookings, owners use, maintenance, hurricane haul out, etc. It will be important to keep us informed when you take dates off the calendar. Any dates shown available on your calendar, [e-yachts.info](http://e-yachts.info) will consider open for charter bookings.
3. Also included in this package is an Authorization for Central Agent for Nemesis Marketing. [e-yachts.info](http://e-yachts.info) partners with Nemesis Marketing in the production of your e-brochures. We will need digital photographs for this purpose. A list of necessary photographs & specifications for them is enclosed herein.

["e-yachts.info"](http://e-yachts.info) assumes **"no liability"** for vessel's keeping up to date with documentations, registrations, Captain's license and STCW certificates, insurance binders, professional scuba certification/insurance, copies of passports for all crew and visas and any other documentations needed to run charters that are not mentioned above.

## **e-yachts.info LISTING AGREEMENT**

Upon signing this agreement and payment of the startup fees in effect at the time of signing and billed on the \_\_\_(date-\_\_\_\_)\_\_\_ of every month thereafter, **e-yachts.info** will act as the exclusive calendar clearing house for the vessel: \_\_\_\_\_ which is actively engaged in the business of term crewed chartering.

### **e-yachts.info WILL:**

- Make known to our current published list of qualified brokers all pertinent information about your vessel to include specification sheets, rates, available dates and crew information;
- Confirm charters on subscriber's behalf and issue a confirmation number;
- Distribute broker's request for brochures to the yacht's contact person;
- Confirm that each charter deposit is received at the appropriate time and report to the subscribing yacht upon receipt (or non receipt) of the deposit.

### **SUBSCRIBER WILL:**

- Complete **e-yachts.info** yacht information (specification sheet);
- Provide and update crew information;
- Provide and update seasonal rates on a timely basis (at least three months in advance);
- Inform **e-yachts.info** immediately of any crew changes, planned sale of vessel or any other occurrences that would affect the availability or suitability of the yacht for charter.

### **BOOKING PROCEDURES:**

**e-yachts.info** is authorized to commit subscriber's time to brokers (i.e. our confirmation number given to a broker is as valid as signed contract) provided the following conditions are met:

- Dates are open and rate is published on **e-yachts.info** rate sheet;
- Number of guests are in agreement with your yacht information sheet provided to **e-yachts.info** or any subsequent written changes you have made and which have been published to brokers in our rate sheet and Website;
- Any other stipulations Captain and/or Owner has made in writing and which have been published to brokers.

### **ARBITRATION:**

Any disputes will be resolved by binding arbitration.

**RIGHT TO SET OFF:**

When a vessel subscribes to **e-yachts.info** services and utilizes said services, both the Owner and the Captain are mutually responsible for all charges incurred. The Captain and Owner also agree to **e-yachts.info** "right to set off" any overdue, unpaid charges by using charter deposit monies for the vessel or credit card on file (which are dispersed ten days prior to the start of a charter) to which the vessel is currently entitled.

**COMMISSION:**

A Broker's commission is considered an earned fee when he/she confirms the sale of a charter aboard your vessel. Should you cancel a confirmed charter for any reason, you are responsible to the broker for this commission. This is regardless of whether or not the charter is placed on another vessel.

**LEGAL RESPONSIBILITIES:**

The Captain and Owner affirm that they are aware of and complying with all legal and jurisdictional requirements, rules and regulations, and licensing pertaining to the operation of their charter yacht in U.S. and foreign waters. Nothing in this Listing Agreement should be construed as creating an agency relationship between **e-yachts.info** and Captain or Owner.

The subscriber agrees to pay \$150.00 monthly plus 1% or a \$30 minimum handling fee for each charter booked. Prices are subject to change. All bills are payable upon receipt and failure to keep account current on a monthly basis will result in **e-yachts.info** right to set off charges or may result in all services being discontinued.

## LIST OF PHOTOGRAPHS NEEDED

While we can, by special agreement with Nemesis Marketing, begin your e-brochure with one photograph we suggest you supply as many of the photographs shown below at the time of subscription. The photographs are required within thirty days of subscription agreement signing. We can resize photographs for you but have included the pixel size for your convenience.

⌚ Side Image of Yacht - Running or at Anchor/Dock (**#1**). This is the picture of the yacht. It is usually a side view but can be aerial. This photo cannot be more than 500 pixels wide. This photo is **REQUIRED** in order to set up initial e-brochure and activate your information in the search engines on the website. Images below are required (where marked) within thirty days of signing.

⌚ All boat logos must be a maximum of 300 pixels wide. Logos are Optional

⌚ Images in this section of your brochure must be 350 pixels wide by 263 pixels high. Again,  can resize your photos if necessary. The following photos are **REQUIRED**.

1. Main Salon – 1 photo required

2. Formal Dining/Dining Area - 1 photo required

3. Any Exterior/Interior image such as Aft Deck/Cockpit/Galley/Wheelhouse/Nav Station etc. (NOT INCLUDING GUEST CABIN IMAGES) – 2 different photos required

4. Master Cabin Bed – 1 photo required

5. Guest Cabin Bed or Master Stateroom Bathroom – 1 photo required

6. Guest Cabin or Bathroom – 3 different photos required

7. Miscellaneous photos – there are spaces for 8 additional photos of miscellaneous items such as guest having fun, pretty sunsets, crew having fun, etc. These photos are optional but add a great deal to your e-brochure.

8. Photos for sample menus. These photos are optional

⌚ Crew Photograph – This photo cannot be more than 500 pixels wide. This photo is required.

⌚ A layout diagram. Photos in this section **CANNOT** be more than 500 pixels wide. Layout should face from left to right. This photo is optional.
